## **Colorado Springs Charter Academy Board of Director's Meeting April 17, 2023 Head of School Report By Zoe Ann Holmes**

### **Enrollment:**

- Current enrollment for grades Kindergarten through 8<sup>th</sup> Grade is 299.
- Enrollment for the 2023-2024 year is taking place. Information Nights continue and enrollment for students continues.
- An agreement with Effect.org has been signed and a virtual meeting/training has been set for April 27<sup>th</sup>. This organization will take on the marketing for CSCA and will find leads of interested families for enrollment.

### **Safety/Security:**

- We had an individual throw a baseball through a window in the cafeteria late at night, breaking the glass. Mrs. Anizell first discovered the shattered glass and took an initial picture. Mrs. Holmes made the report to the Colorado Springs Police Department, with the help of Mr. Dolley, sending in pictures and video of the incident. Mr. Lancaster cleaned up and ordered the new glass panel.
- Individuals on motorbikes have been riding on our playground as well as our lawn in the back of the school. Ms. Pardo asked them to leave from the back lawn or the Head of School would report it to our CSPD.
- Ms. Pardo will be moving out of the CSCA rental house by the end of May, making it available for our administrative team to further check out needed repairs.
- The Department of Health is partnering with Carrier to provide clean air for schools and CSCA has been able to sign up for this three-year program that provides free air purifiers and air filters for classrooms. There is no cost for our school, and when the three years are up, the purifiers remain with us, and filters would no longer be free, as CSCA would need to purchase the filters.

### **Academics:**

- Colorado Measure of Academic Success (CMAS) is our State testing and CSCA has nearly completed all make-up tests for any students missing our testing dates. Thank you to each staff member giving the tests and to Mrs. Anizell who planned and organized the testing process for CSCA. Results for CMAS will be announced in late July of 2023.

- Our Kid's Focus program has been helpful to identify student's areas of needed growth, as well as add to our staff's ability to collaborate, document interventions, and receive support from our Reading and Math Interventionists.
- Recently, several teachers and educational assistants have commented positively on the Core Knowledge Language Arts curriculum, that we are still in the initial year of utilizing. Several teachers thought by using CKLA that their students were better prepared for the CMAS Writing test.

#### **Assemblies and Events:**

- We held our Third Quarter Awards Assembly to honor our students who have earned awards for EPIC character as well as academic and core virtue awards.
- COS I Love You has accepted CSCA as a volunteer project with collaboration with our families on April 29. We have identified landscaping and painting projects as well as assisting in putting staff appreciation bags together. We invite our families and local businesses to work with COS I Love You to work on these projects and build community with this group of volunteers. We welcome each of you to join as partners with our community members and come to the school prepared to collaborate in work to improve our facilities.
- A fundraiser continues for athletic funding for uniforms and equipment. This fundraiser still needs additional support.
- First Grade is excited for a trip to the Cheyenne Mountain Zoo with parent chaperones.

#### **Staffing Changes:**

- We've offered an engagement letter to Hannah Badeau, a licensed social worker who will join our Lynx team in August of 2023. Hannah comes to us with experience and will be an asset to our students, staff, and families.
- Mr. Campagna, AD, has been walking through the process of reviewing applicants and interviewing candidates interested in coaching basketball for our boys' and girls' teams for next year. Mrs. Holmes has been in the interviews for qualified candidates. We are planning on scheduling camps and clinics to be held in our gym this summer.
- Mrs. Gumpf, 5<sup>th</sup> grade Educational Assistant for 5<sup>th</sup> grade just recently resigned due to the need to provide further financial support while her husband is deployed in the military.
- We have made an offer for our teacher of Special Education, and unfortunately the offer is lower than the current salary of the candidate. We will continue to seek qualified candidates for the Special Education position.

#### **Student Performances and Activities:**

- Art Club, Choir, Band continue as after-school programs.
- Several of our younger students were invited to The Lodge at Palmer Point, a residential assisted living home in our community, for an Easter Egg Hunt with the residents. We would like to invite our neighborhood friends to also attend our events as we collaborate.
- Spanish classes have been hosting an event to support The Pulsera Project, in which individuals from other countries make bracelets and small bags to support individuals who otherwise don't

have enough income or are unable to attend school due to financial constraints. All funds go directly to the project and students working with Mrs. Moreno, were able to communicate about the project, and to make the sales of the pulseras.

- Our track team has 15 dedicated students who have worked hard and have trained in all types of weather for their track meets, held on Saturdays.
- Landsharks Running Club holds practices on Wednesdays and Thursdays, with three meets being held Sunday afternoons.
- The Art Show and a Spring Music Concert are coming up to display the talent of our students, so check the school calendar on the website for details.

#### **Dashboard Items for Collaborative Work:**

- Budget meetings are taking place in collaboration with our accounting firm to set the 2023-2024 budget.
- School Accountability Committee (SAC) is meeting to plan events for interested students and families to meet the goals set by the SAC. Friday night is a Family Board Game Night to be held at CSCA. This committee is looking at data in the areas of reading and math over recent years to be able to set goals for the Unified Improvement Plan, (UIP).
- Policy updates are needed as we go forward, and calendar work for the 2023-2024 will start soon.

#### **Opportunities:**

- A volunteer is needed to assist in the cafeteria with setting up, serving, and cleaning up each lunch from 11:30-1:30 each day.
